### *LIVE AND VIRTUAL 2021 ANNUAL CONFERENCE SCHEDULE & REGISTRATION*

**Due to Covid-19 restrictions the Idaho Society of Professional Land Surveyors is currently offering both live and virtual options for the 2021 Annual Conference. Please note this is subject to change depending upon Covid conditions and/or numbers registered by January 15, 2021. Registrants will be notified by January 15 if we determine we have to go all virtual.**

**LIVE**—Those choosing to attend live in Moscow may do so but restrictions **limit our numbers to 85 attendees**, first come first served. Masks and social distancing will be required. If we do not have **75 people registered to attend by January 15**, the live portion will be cancelled.

**VIRTUAL**—The virtual option will require attendees to have access to a computer to take these classes from their office or home and to be able to access the Zoom platform (Note: Some companies/agencies do not allow Zoom access from their servers—please check with your organization). Your computer does not need audio (the webinars can be accessed by phone) or camera but both capabilities are highly recommended to improve your experience. Make sure your internet connection is good. These classes will be live with the opportunity to ask questions in real time of your instructors, and to make comments. Attendance will be verified with occasional live polls during the class asking the attendee to respond and by an evaluation at the end.

Once you register for classes you will be sent, via email, on the Friday before the event the link to enter the appropriate seminars. You can enter the seminar through your browser (Chrome gives best result) without downloading the Zoom app but downloading the app is preferable for a better experience. The app can also be downloaded on your phone. All classes will be activated 15 minutes early so you have a chance to connect and test your connections. We will also conduct an optional “test” for those unfamiliar with the platform a half hour prior to the webinars so you can get on early and make sure all technology problems are solved.

## 2021 ANNUAL CONFERENCE AND MEETING
